# March 17, 2022 Minutes Port of Alsea Regular Board of Commissioners Meeting 365 Port Street, Waldport, OR 97394

# I. CALL TO ORDER

President Rob Bishop called the meeting to order at 2:00.

### II. APPROVAL OF THE CONSENT CALENDAR

Cuellar updated the commissioners on the new accounts purchasing crab measures. She also explained that the Port now has ACH insurance with Columbia Bank to protect the Port from scams. She also told the commissioners that Dann Cutter told her that he thinks there would still be parking available for the Port at the museum property even if Green Bikes leases the building. Cuellar also told the board she has had no additional contacts pertaining to the kayak race at the Port. She told the board the new \$10.00 launch fee is now being charged at the pay station. She also provided the board with reminders about how executive sessions are handled under Oregon law.
